REPLY DECLARATION OF JASON A. ZWEIG IN FURTHER SUPPORT OF FINAL APPROVAL OF THE PROPOSED SETTLEMENT AND PLAN OF DISTRIBUTION, AND CLASS COUNSEL’S APPLICATION FOR ATTORNEYS’ FEES, REIMBURSEMENT OF LITIGATION EXPENSES, AND PAYMENT OF SERVICE AWARD TO PLAINTIFF HENRY H. BRECHER

JASON A. ZWEIG hereby declares as follows:

1. I am a partner in the law firm of Hagens Berman Sobol Shapiro LLP (“Hagens Berman”), the Court-appointed class counsel in this matter. I am the Hagens Berman partner currently handling this matter on a day-to-day basis. I have personal knowledge of the matters stated herein and, if called upon, I could and would competently testify thereto.

2. Since notice of the Settlement has been disseminated to members of the Class in June and July 2016, I have fielded dozens of inquiries from members of the Class, and potential members of the Class concerning this litigation and the Settlement. These inquiries related to a variety of issues including the amount of attorneys’ fees Class Counsel was seeking, the difference between the Settlement and the Public Settlement Offer made by Argentina, and the timing of the


Settlement payment. Most of the inquiries came from class members in Italy. Many of them only spoke Italian, and I communicated with them in Italian using Google Translate.

3. In addition, I personally communicated with almost every class member seeking additional documentation from the class members in order to substantiate their claim, and to verify details of their claim to ensure such claim was invalid. Almost all of the class members reside in Italy. Many of them only spoke Italian, and I communicated with them in Italian using Google Translate.
